General Data Protection Regulation (GDPR):

The data you provide will be processed by the Boulderverein BLOC HOUSE & Austria Climbing as the responsible party for the purpose of COVID-19 prevention measures for events in accordance with Art. 4 Z 7 GDPR on the basis of contract performance.

These are the data categories first name, surname, e-mail, phone number, residence address, country of residence. The transfer of personal data from you to third parties is only provided in fulfillment of contractual obligations or legal obligations that apply to us. This is mainly necessary for the administration and fulfillment of the contracts with you or other obligations incumbent on us towards authorities and public bodies (e.g. health authorities). The transfer of personal data to other third parties is not intended. If such data is passed on to third parties, corresponding (order processing) agreements are made with them or there are legal obligations to pass on data in this respect. The data will be stored for a period of 4 weeks from the date of collection.

There is no intention to transfer the data from you to a third country or an international organization (Art 13 para 1 lit f GDPR). According to Art 13 para 2 lit b GDPR, you have the right to information about the data at any time according to Art 15 GDPR, the right to rectification according to Art 16 GDPR, deletion according to Art 17 GDPR, the right to restrict the processing of the data according to Art 20 DSGVO, the right to data portability according to Art 21 GDPR, the right for decisions that are not based exclusively on automated processing - including profiling - according to Art 22 GDPR. You have the right to lodge a complaint with the supervisory authority. (Art. 13 para. 2 lit. d GDPR). The competent supervisory authority is the Data Protection Authority, 1082 Vienna, Wickenburggasse 8. The provision of personal data from you is necessary for the performance of the contract. Without this data, fulfillment of the contract is impossible and the contract would then not be concluded or dissolved by us (Art. 13 para. 2 lit. e GDPR). There is no intention to process the data from you for automated decision making including profiling (data analysis on behavior, habits, preferences...) (Art 13. Abs 2 lit f GDPR). To protect your personal data with us, we have taken appropriate technical and organizational measures in accordance with the provisions of Art 32 GDPR.

Declaration of Consent:

I or my legal representative, if any, am aware of the fact that by participating in the above mentioned sporting activity a risk to my physical integrity - also with regard to an infection with the COVID-19 virus - is possible. I have weighed up this risk and expressly accept it with my participation in the sporting activity. Furthermore, I waive to this extent any claims for compensation against the operator of the sports facility or organizer of the sporting activity in the event of such an infection, provided that they or the persons attributable to them do not act intentionally or with gross negligence.

I, as a participant, expressly acknowledge that the above-mentioned sporting activity will take place in compliance with the provisions of the laws, regulations, directives and decrees issued to deal with the Corona crisis and confirm that I am aware of all these legal provisions. Furthermore, by entering this sports facility during the stay, I undertake to comply with the legal provisions or the house rules and the general regulations of the federal sports federation responsible for the sport performed, as well as with all the guidelines and directives and recommendations issued by the federal sports federation responsible in connection with the Corona crisis.

I acknowledge that the operator of the sports facility or organizer of the sporting activity is entitled to monitor compliance with the above regulations. This concerns, in addition to the keeping of booking or access and stay systems and records, the use of security personnel or video surveillance. Furthermore, I undertake to comply immediately with any instructions given by the operator of the sports facility or organizer of the sporting activity or their authorized third parties to comply with the above regulations. Otherwise, they may also issue a reprimand from the sports facility or exclusion from the sporting activity. I must also comply with any reprimand or exclusion without delay. I confirm that I am not knowingly infected with the COVID-19 virus or that I have not been in contact with persons infected with this virus in any way during the last 10 days.

I further certify that I am currently not in quarantine as a result of contact with an infected person, and that I am not a member of any of the risk groups under the regulations relating to the management of the Corona Crisis. In case of non-compliance with the COVID-19 regulations or a violation of the contents of this declaration of consent by me, I am liable to the operator of the sports facility or the organizer of a sports event. I expressly agree to indemnify and hold them harmless, without exception, in the event of a claim being made against them by a third party on the basis of a breach of this declaration of consent by my entering, staying and/or behaving on the sports facility for any reason whatsoever.
